North Florida Area 14 Panel 63 is putting on a Literature Challenge with Genet encouraging participation. A 5 page handout with instructions and literature list was distributed. This is scanned and attached as well.

The February meeting of the Nature Coast Intergroup hosted eight groups. All officers and three of the four trustees were present.

Both the Secretary and Treasurer's reports were accepted as read. The trustees reported on completion and results of the annual financial audit. "The audit went well and after careful review all was in order and the books balanced." It was recommended in future that invoices or receipts be presented for payment by check and that checks should require two signatures. An updated Where and When is underway. Currently 36 groups/meetings are represented with 46 groups/ meetings in existence. General Service Office in New York will not recognize a group/meeting until its paperwork is generated by the district and area. It was agreed that as a group, intergroup needs to encourage participation. A new publisher is under consideration for the Nature Coast Intergroup Journal. Initial discussion was tabled and moved to New business. The webmaster reported 18,742 hits to the website for the month of February, 604 hits per day with 95 visits per day with the majority of visits cited for NCI Journal and Where and When viewing. The Nature Coast Intergroup has a new P. O. Address: Nature Coast

Intergroup, P.O. Box 2634, Crystal River Florida, 34423. The website address has remained the same; www.ncintergroup.org. The hot line chair reported receiving 96 calls from January 26 through February 24. Under Old Business, a storage unit was rented for use by both the Nature Coast Intergroup and District 28 with the monthly rent shared equally. Under New Business, a discussion of the Nature Coast Journals publication ensued. It was determined that further definition and discussion was need and an editorial committee would be appointed.

New Business:

An exception was asked for due to our current treasurer on a leave of absence, to move forward at this meeting. A group conscious was given by the group without objection. The motion was then seconded and passed unanimously.

A motion was offered for District 28 to purchase 10 copies of BOX 4-5-9 to have on hand at a price of \$6 a year. This was seconded and passed unanimously.

Willye M. brought up that treatment was getting low on necessary literature due to the increase of outreach success. Discussion brought out for treatment to use the funds currently budgeted and if additional funds were needed this could be brought before the District for approval.

A volunteer was asked for to assist with the treasurer duties on a temporary basis during the leave of absence. Paige B. was kind enough to agree to help out. A motion was offered, seconded and it passed unanimously.
