Old Business:

At the last meeting Paula asked everyone to give some thought to suitable topics for our next District workshop, and this discussion was renewed. Announcement of a proposed workshop was made to the home groups but there was little feedback. The suggestion of having a “Wet Drunk” workshop was presented. It has been several years since a workshop on that topic was held. In the past District 28 has partnered with NCI and surrounding District groups. Paula remarked that a former DCM, Dan E., does a really good job on the topic, and perhaps he would agree to facilitate the workshop for us.

The concept of “Wet Drunk” workshop could take in a lot of different considerations, and a discussion was held on what would be a proper focus for our program. It was noted, for example, that if someone is in immediate need of transportation to a treatment facility, the hotline responder should have another recovering person present during the transportation. Rick T., who handled the hotline for three years, advised that calls came in at all different hours. It is important to have a current list of men and women 12th Step volunteers from different areas of the county so that appropriate referrals can be made. It was suggested that perhaps religious clergy could be invited, as some have received training in the area and may be willing to serve or provide assistance to responders. It was acknowledged by the group that the Hotline is one of the most important outreach functions of AA, as it is where so many people in need turn first for help. There are some special issues in the 12th step process, including how much a person has had to drink, how long since the last drink, and are the “DT’s” a concern.

From the discussion it became apparent that perhaps the original concept of “Wet Drunk” workshop was too narrow and could be expanded to cover more issues than initial contact. Paula asked for suggestions for a broader topic name and received several good suggestions from the group. As a first order of business, there was a motion and second that we have such a workshop; the motion passed without opposition. A motion was then made to have Paula contact Dan E. to see if he would help facilitate the program. This motion was also seconded and passed. For planning purposes, a discussion was held regarding an appropriate date for the workshop. In addition to the time frame between August 16 and September 27, the month of October might also be appropriate. We will try to work around Dan E.’s schedule.

After additional suggestions for a formal topic of the workshop were made and discussed, a motion was made, seconded and passed that the title of the workshop would be "I Am Responsible: The 12th Step In Action." Paula will check on Dan's availability, with a view toward an October date, and will coordinate with Paige regarding the NCI calendar.

New Business:

- A. A proposal to consider collecting old Grapevine magazines for re-distribution was tabled to the next meeting.
- B. The question of establishing a recommended limit on service positions that could be held by one person was also tabled to the next meeting. It was noted that honoring the spirit of rotation of positions is important to encouraging people to become active in service.
- C. Regarding the possible need for a new Chairperson of the Treatment committee, Paula acknowledged this is something to be considered, and if anyone wants to help in the meantime, it would be appreciated. Al M. pointed out that the problems of the current chairperson were not his fault. New security rules have been imposed by CCA and it is difficult to set up meetings.

As a general proposition, Paula reminded everyone that a chairperson's position is also partly administrative in nature. It is okay for a chairperson to get other people to help out, and to delegate tasks to willing volunteers.

The Meeting was adjourned at 7:05 p.m. upon motion made, seconded and passed unanimously.
