Secretary’s Report:

Everyone had received copies of the Minutes of the July 31, 2016 meeting, which were approved upon motion and second.

Treasurer’s Report: Jen B.

Jen presented the final Report through the end of July, 2016, consisting of the Income and Expense Sheet and Contribution Report; copies were distributed to everyone. The Income and Expense Sheet showed a beginning balance of \$3768.35; income from contributions, 7th Tradition collections and Pink Can donations in the amount of \$368.00; expenses of \$855.72,

and an ending balance of \$3280.63. Upon motion and second, the Treasurer's report for July was accepted.

Jen also presented a preliminary summary of the monthly report for August, which had a beginning balance of \$3280.63. There had been some Pink Can and other donations, some checks had been written and it appeared that the closing August balance would be \$3605.18.

Thank you for the opportunity to grow and serve Alcoholics Anonymous through District 28’s Literature Committee. In the doldrums of summer, the Literature Committee examined the published Service Material and focused on The AA Preamble: Background Material:

AA PREAMBLE©

Alcoholics Anonymous is a fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism.

***** (1) The only requirement for membership is a desire to stop drinking. (2) There are no dues or fees for AA membership; we are self-supporting through our own contributions. AA is not allied with any sect, denomination, politics, organization or institution; does not wish to engage in any controversy, neither endorses nor opposes any causes. Our primary purpose is to stay sober and help other alcoholics to achieve sobriety.***

*****Bold font and numeration are mine and not part of the Preamble.***

The Preamble was introduced in the June 1947 issue of the AA Grapevine magazine. The original version differed in two ways from the familiar form we all know: 1) It stated that the only requirement for membership is an “*honest* desire to stop drinking,” and 2) it contained only the very brief statement “AA has no dues or fees.” The word “*honest*” was deleted in 1958. A delegate to the General Service Conference suggested that since “*honest*” does not appear in the Third Tradition, it might be deleted from the Preamble. Discussion followed and in the midsummer meeting of the General Service Board of Trustees the deletion was ratified. Since then, the Preamble has read simply “a desire to stop drinking.” At the same time, the phrase “AA has no dues or fees” was clarified to read as it presently does: “There are no dues or fees for AA membership; we are self-supporting through our own contributions.” AA has evolved and is continuing to do so...we, as members, miraculously do the same! Thank you for allowing me to serve.

Things are going well at the Centers in Lecanto. The Women's meeting continues. Lynn has been helping out and had some volunteers. There is an AA meeting for the women every Sunday evening, mostly younger women. And they are going well.

NCI Liaison: Dean B.

Meeting was called to order by Chairperson Rick T. with a moment of silence followed by the Serenity Prayer.

Jen B. took Roll Call. There were 11 groups present and 19 members in attendance with 4 visitors. There were no new Reps.

Secretary Jen B. read the minutes from last month's meeting and they were accepted as read.

Treasurer Paige B. read the final expense report for July. Beginning balance of \$3,229.42, ending balance of \$3,139.20. Accepted as read. Paige B. went over the draft for August.

Trustees Reports: Janet B., Sandy H., and Bill M. had nothing to report. Denis S. reported that Events are still being run well.

Hotline Report: Gail K. of the Won Rebos Group reported 28 calls. Three active wet calls, the rest looking for meeting locations. Thank you Won Rebos for stepping up for the month of August.

Website Report (ncintergroup.com): Webmaster Steve N. reported 586 sessions by 425 different users in the past month. Each visitor looked at an average of 3.22 pages. Of special importance is that 276 or 47% of the sessions and 150 or 35% of the unique users were on mobile devices.

The overall bounce rate was a phenomenal 47.27% indicating when visitors arrived they stayed and processed our information. The mobile device bounce rate was even better at 43%.

The 10 most visited pages were Meetings in general, Meetings by Day (days in order were: Wednesday, Tuesday, Sunday, Saturday, Friday, Monday, and Thursday), Meetings by Location, NCI Calendar, Newcomer Information, Contact Information, Information Links, Minutes, Young People, and Contributions. The most downloaded items were: Traditions mp4 by Chet P., State Convention Flyer, Where and When, Journal 01/2012, Journal 01/2012, Journal 02/2016, and the Responsibility Statement.

Alternate Chairperson Steve N. reported he is heading up the committee for re-locating our meeting location, and he congratulated Chairperson Rick T. for the work he has done with and for NCI.

Journal Report: September issue will be going out next week.

Events: Rich reported for Lynn that Events are being managed well.

Speaker for the Picnic in the Park is being worked on, and we need grills and vehicles to haul stuff to the picnic. Chili Cook-off is slated for October, location to be determined.

Old Business: Motion from last month's meeting to create a position for an Alternate Treasurer was discussed. Structures and Guidelines state "changes can only occur at the Annual Meeting in January or at a special meeting declared for that purpose." A special meeting will be held during the regular monthly meeting in October.

No New Business.

Motion to Close was made and we closed with The Lord's Prayer.

Workshop Committee: Jay B.

Jay would like to schedule a workshop for the last part of October, either the 22nd or the 29th. He has reserved the meeting facility at Our Lady of Fatima for those dates and has to let them know which one we will use. He has several topics available, but would like to use this occasion for a workshop on “How to Chair an AA Meeting.” This is a topic on which there will be a lot of input and a lot of different opinions, which is good. The group agreed that this would be a good topic and the consensus was that October 22 would be the best date. There were some concerns raised about the date for the Chili Cook-off but it was ultimately decided we could work around that if necessary and go to the 29th. So it is the plan to do the “How to Chair an AA Meeting” workshop on October 22nd.

Website Committee: Steve N.

There were 967 sessions by 736 different users in the past month. Each session visitor looked at an average of 2.15 pages. The ten most visited pages other than the start page were meetings, help now (hot line number), legacies, contact us, calendar, where and when, information links, archives, about us, and mobile. The most downloaded items were training video, training audio, where and when, state convention flyer, picnic in park flyer, Florida unity flyer, long timer meeting flyer, and legacies.

People sought meetings by location in the following order: Inverness, Dunnellon, Lecanto, Floral City, Inglis, Holder, Homosassa, and Crystal River. The meetings sought by day in order were: Sunday, Friday, Tuesday, Wednesday, Monday, Saturday and Thursday. An interesting statistic is that the hours of most visits were 1 and 2 p.m. followed by midnight and 1 a.m.

For those still hung up on hits, there were 10,128 total hits in the past month by 1,037 unique visitors.

I Am Responsible!***

I can certainly testify that a mighty change took place when I turned from being a "loner" to being a "volunteer" - a "trusted servant." When I was newly sober, I wasn't ready for very many responsibilities beyond greeting people, opening the meeting room door, making coffee and doing even that much seemed like a big concession on my part. As I developed in sobriety by working all of the steps, my responsibilities came to be greater. I was asked to go on Twelve Step calls. I was asked to lead meetings. I was asked to speak at meetings. I was asked to be an Intergroup rep and a GSR. Men asked me to sponsor them. My responsibilities kept getting progressively more demanding until I became your DCM. I cannot tell you how much I have come to know through your help that I need to hear the voice of sobriety within me and accept new responsibilities because the more service I give, the more I grow and the easier it is to stay sober. Responsibility and sobriety go hand in hand for this alcoholic. I urge you to try it!

Old Business:

1. District Business Meeting Relocation Committee. I have the honor of heading that up. If anyone would like to help us or know of any possible locations, please let us know.

2. Pink Can funds. The question raised at the last meeting was whether funds raised in a non-profit organization can be designated for a particular purpose. Steve researched this issue and has could find no legal research indicating that there would be a problem with what we are doing; the practice of designating funds is acceptable legally and consistent with an organization of this size and nature. We are not a non-profit corporation. The concern of the IRS was with 'money-laundering,' which is not an issue here. The IRS had found instances of major non-profit corporations accepting large contributions that were supposedly ear-marked for a particular purpose, with the money then being laundered and used to take over or otherwise divert the corporation from its original purpose. In our case, not only are we a very small entity, but we are self-supporting through our own contributions; we do not solicit or accept outside contributions and there is no danger of us being taken over by a large contribution that makes a large contribution. An accountant familiar with accounting for non-profit associations has been consulted. It was suggested, for transparency, that a separate line-item be maintained to report the income and expenses associated with the program. Use of the term "designated" as opposed to "earmarked" was recommended. In the future, we will use the term "designated" rather than "earmarked" when referring to Pink Can funds. The program is working very well. Lisa B., from

Won Rebos, confirmed the success of the program at her group. Jen noted that we had received approximately \$121 in the first two months.

New Business:

A. Elections. Steve reminded everyone that election of District 28 officers will be held at the next meeting and read the resumes that had been submitted this far: Paige B. for DCM and P. J. O. for Alt. DCM. Steve advised further that Sandy H. (II) had very recently submitted a resume for the position of Secretary via email, which was read to the group. All resumes would be attached to the minutes. No one had submitted a resume for the Treasurer position and no offers to stand for election to any position were made from the floor. Home groups should be advised that resumes for all positions can be submitted any time including the next meeting.

B. Consider changing the date of the monthly meeting. This task is also part of the Meeting Relocation Committee's work. The meeting date is set by our Structures and Guidelines so we will need to review that. What we would like to do is change the meeting date to the second Sunday of each month. We believe this would avoid conflicts with the major holidays in most years, and it would simplify the Treasurer's job to some extent. Sandy H.(I) volunteered to help Steve on these issues, and Steve welcomed anyone else who would like to assist. There may be an issue with regard to amending the meeting time. Because these changes would involve a conflict with Structure and Guidelines as presently constituted, any proposed change would have to be laid over before a final vote. Paige agreed that the proposed change would be a good idea. However, it was noted that there may sometimes be an Area 14 Assembly on a second Sunday. These matters are referred to the now-renamed Relocation and Time Committee for study.

C. Budget. Jen pointed out that Post Office box fee had increased this year from \$56 to \$60, and we had budgeted \$56. We need to amend. A motion to amend to \$60 was made, seconded and allowed.

D. Budget. Jen pointed out that we had some additional events and we had a workshop coming up. We are in excess of the budgeted \$200, so we need a motion to increase. A motion to increase the Workshop-Special Events budget from \$200 to \$325 was made, seconded and allowed.

Announcements.

The next Journal will be published in September.

Tradition 8 and Concept 8 will be sent out with the July Minutes.

Upon motion and second, the meeting was adjourned at 6:55 p.m. followed by the Lord's Prayer.

Tradition 8 and Concept 8

Tradition 8: "Alcoholics Anonymous Should Remain Forever Nonprofessional, but Our Service Centers May Employ Special Workers"

There is a saying heard in the rooms, "In order to keep it, you must give it away," with the key word being "give." As Step 12 says, "Having had a spiritual awakening as the result of these Steps, we tried to carry this message to others, and to practice these principles in all our affairs." The 8th Tradition ensures that anytime a newcomer reaches out for help, he will receive it, free of charge. Members freely share their own experience, strength, and hope with the newcomer and by doing so, help themselves by reinforcing their own recovery in the process.

Many times, newcomers to the program will go to their first meeting expecting to find trained professionals who are there to help them. What they find instead is a fellowship of equals who are gathered together for mutual support. There are no doctors, therapists or counselors, only other members who have or have had the same problem in their lives. That's not to say, some of those members are not doctors and professionals, but they leave those outside affiliations at the door.

It's how the AA program works. Giving it away in order to keep it.

On the other hand, AA organizations at the national, state and sometimes regional level do have service centers which serve the fellowships as a whole by printing and distributing literature and meeting schedules, maintaining answering services, and other tasks. These central offices and service centers many times involve more work than volunteer service workers can provide, so some do hire full- and part-time employees to do the necessary labor to keep them running smoothly.

Tradition 8, therefore, allows for the "special workers" to be hired and paid a salary to do the work that volunteers cannot cover.

The sacrifice for tradition 8 as described by SE Trustee Chet A. is that we sacrifice the right to be paid for sharing the message we received for free to others. The 8th Tradition is so very simple but greed no matter how you try to rationalize it, is still greed. As it is implied in our 8th Tradition: "freely ye have received, freely give". Twelfth-step work should not be paid for! Both AA members lose, the newcomer is already in an outsider's position because of paying for services, the paid "professional" offering the message of AA is put in a position to compromise all that he is offering because of his profit. He loses what AA has given to him big time.

The questions we must ask ourselves about tradition 8 from the Grapevine are:

1. Is my own behavior accurately described by the Traditions? If not, what needs changing?
2. When I chafe about any particular Tradition, do I realize how it affects others?
3. Do I sometimes try to get *some* reward—even if not money—for my personal AA efforts?
4. Do I try to sound in AA like an expert on alcoholism? On recovery? On medicine? On sociology? On AA itself? On psychology? On spiritual matters? Or, heaven help me, even on *humility*?
5. Do I make an effort to understand what AA employees do? What workers in other alcoholism agencies do? Can I distinguish clearly among them?
6. In my own AA life, have I any experiences which illustrate the wisdom of this Tradition?
7. Have I paid enough attention to the book *Twelve Steps and Twelve Traditions*? To the pamphlet *AA Tradition—How It Developed*?

Concept8: "The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities."

While this concept talks about the heavy duty obligations and duties of the trustees of AA as a whole, it also reminds each AA that we too must be responsible. We need to examine our willingness to be responsible by asking ourselves some simple questions:

1. Am I willing to volunteer to clean up after A.A. meetings? Am I willing to serve as Secretary, Leader, Speaker, Coffee-maker, Intergroup Service Representative or General Service Representative? Am I willing to take directions? Have I stopped saying "no" in my heart to any

A.A. requests that involve responsibility? Am I responsible about going on any A.A. twelfth step calls when asked, day or night?

2. Am I willing to be responsible in love relationships and at work? Am I spiritually responsible for what I think and for my emotional moods? Am I willing to be responsible for my spiritual condition through working a program or do I still expect others to take care of me because I am unwilling to be responsible for myself?

The basis of this concept is that we are of service to others by following God's directions. He plans and administers our lives and oversees all. He expects us to carry out our responsibilities in his grand design. We are vital and important to God. He needs us! He delegates to us the privilege and responsibility of carrying the message. In this concept, Bill describes the importance of keeping separate the functions of custodial oversight and executive action. We should see this idea as a parallel to our relationship with our Higher Power. God oversees our lives and expects us to take action. We are not to be in charge of life and execute. We are here to execute only.

Although we are not trustees, we have a parallel responsibility. In working this concept, we should make A.A.'s motto our own: "I am responsible when anyone, anywhere, reaches out for help. I want the hand of A.A. always to be there: And for that, I am responsible." Each of us from Trustees to ordinary members has as their responsibility to see that we act in a way that will ensure AA continues for all alcoholics to follow us.
