District 28 Web Report March 5 2017

There were 1529 visits to the website in February by 755 unique visitors who visited 3261 pages or 2.1 pages per visit. Alt. DCM report for March 5, 2017

I met with the other District officers to update information and put together an Agenda for the monthly meeting. Regarding our Resource Page, in addition to the normal changes that occur, I will be comparing the information on our list with the group list for our Area 14 that is maintained by the Area Registrar. Sometimes there are differences between the two, and it can be challenging to find out which list is in fact accurate. It is really important for the home groups to communicate with both District and Area 14 when there are changes.

I attended the Corrections Workshop at St. Benedict's yesterday in Crystal River. Lina R., our District Women's Corrections Chair, led the presentation. The chaplain Core Civic Correctional facility in Citrus County made some preliminary remarks and stressed the importance of bringing AA into the facilities. Denis S. displayed an interesting video on Corrections service work provided by the GSO. Anthony S., the Area 14 Corrections Service Coordinator, and Bob B., the District 28 Men's Corrections Chair, made excellent presentations. It is clear that sharing our experience, strength and hope as a way to help others recover is at least as important to the incarcerated alcoholic as it is on the outside. We also learned that presentations from recovering alcoholics to incarcerated alcoholics can be a really effective in giving hope to incarcerated alcoholics and helping them find their way to recovery. Bob and Lina noted that in District 28, more volunteers from AA for corrections work are needed and that the need for women volunteers is especially pressing. Paige has our thanks for organizing the workshop.

The next Assembly of Panel 67 of the North Florida Area 14 Conference will be on April 7 through April 9 at the Wyndham Garden Gainesville Hotel, 2900 SW 13 St., Gainesville, FL 32608. District 28 will be reserving rooms for one or two nights as necessary, and will book two rooms for GSRs whose groups are not able to finance that expense. Last year, District 28 hosted this event in Inverness with the support of Districts 13 (Hernando County) and 17 (Marion County). Both Districts 13 and 17 decided to host this event and both asked for our support. Geographically, District 28 is situated between the two districts making it convenient for our members on all sides of the county to attend. The dates are

District 28 hosted a workshop on Saturday, March 4, at the Serenity Club in Crystal River. "Carrying The Message To The Alcoholic Behind Bars," was the theme. A representative of Core Civic, the organization that operates the Citrus County Detention Facility, Reverend Savage and the Area 14 Corrections Coordinator, Anthony S., from Jacksonville, addressed the group of approximately thirty members. Lina R., District 28 Corrections Chair for Women and Bob M., District 28 Corrections Chair for Men, did a super job organizing and facilitating this event. The highlight was Bob M. sharing his story of recovery. The purpose of the event was to encourage volunteers, in particular women, to consider joining the district's effort to carry our message of hope and recovery behind bars. Many thanks go to the Serenity Club for their hospitality and to all those who made this timely and special event possible.

The Citrus County Department of Parks and Recreation contacted all renters of their facility in Holder, including District 28, the Nature Coast Intergroup and several AA groups that meet there on a regular basis regarding issues of housekeeping. The kitchen and bathrooms left in less than acceptable condition and cigarette butts on the grounds, not in the receptacle provided, are chief concerns. There are non-AA renters of the Holder Community Building and no one was singled out.

How we leave this facility after our use says so much about us individually and as an organization Please consider that our actions as individuals and groups do affect us as a whole and if they are contributing to this issue to address and eliminate them.

Old Business:

1. Amendment to Duties of Trusted Servants under Structures and Guidelines Article II, Section E, regarding Archives Chair. The DCM called for a motion to table to change Archivist to Archives Chair, and upon motion and second the motion was moved to table until the next meeting.
2. Service chair stipend to be increased from \$35 to \$50. Steve N. made a motion to remove from table for vote, motion was seconded and unanimously approved. After a brief discussion a motion was made and seconded to increase stipend from \$35 to \$50 received 10 yes and 2 no votes. The minority opinion was then heard and the question was recalled. A second vote was taken which received 6 yes and 6 no votes; since a two-thirds majority was not achieved, the motion did not pass.

3. Co-sponsor Pre-conference agenda workshop in Ocala and Hernando County. The DCM called for a motion to contribute \$25 to each district for their efforts. Upon motion and second, the motion was unanimously approved.

New Business:

1. A proposal to increase the Treatment budget will be addressed at next meeting.

Tradition Three and Concept Three

Tradition III: As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

Why is it good idea for me to place the common welfare of all AA members before individual welfare?

What would happen to me if AA as a whole disappeared?

When I do not trust AA's current servants, who do I wish had the authority to straighten them out?

In my opinions of and remarks about other AAs, am I implying membership requirements other than a desire to stay sober?

Do I ever try to get a certain AA group to conform to my standards, not its own?

Have I a personal responsibility in helping an AA group fulfill its primary purpose? What is my part?

Does my personal behavior reflect the Sixth Tradition-or belie it?

Do I do all I can do to support AA financially? When is the last time I anonymously gave away a Grapevine subscription?

Do I complain about certain AAs' behavior-especially if they are paid to work for AA? Who made me so smart?

Do I fulfill all AA responsibilities in such a way as to please privately even my own conscience? Really?

Do my utterances always reflect the Tenth Tradition, or do I give AA critics real ammunition?

Should I keep my AA membership a secret, or reveal it in private conversation when that may help another alcoholic (and therefore me)? Is my brand of AA so attractive that other drunks want it?

What is the real importance of me among more than a million AAs?

Concept III: As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."
