To be honest I was surprised at the number of people that took interest in the Archives display at the Founder's Day brunch, especially being self-conscience about its small size and just a little of the local history. The two laptops I brought with the History of A.A. on one and District 28 History on the other were both well received, and quite a few people were asking questions and making comments.

Seeing how the pricing on 17" digital picture viewers have not come down to reasonable pricing, in my opinion, I am dropping the purchase of one from the Archives budget. I have found that my laptop is sufficient for any and all displays. If a predecessor needs access I am sure I can accommodate them. I am using one computer with the History of A.A. in Citrus County and a few local items at the State Convention July 27th-30th. I am only allotted a 6' table. That being said, I am asking the District to taking my remaining 2017 budget and increase it to \$150 to help offset Convention expenses. I will not be receiving financial assistance from Area 14. This will help offset expenses towards mileage, meals (\$42/dinner per night), and accommodation (\$119 per night). Asking this is beyond my better judgment, but Paige and I have discussed this at length many times and I guess she finally wore me down. (laughing here)

For those of you planning to attend the State Convention be sure to check out "The Beginning of A.A. in Florida" ..... an original play about the first meeting between Junius C. and Tom S., co-founders of A.A. in Florida, in December 1940 on NAS Jacksonville. The DVD will be playing in the Archives Room.

I am in the process of acquiring an Archives Committee. I am looking for two individuals that do not have a serious service commitment at this time, preferably with organization and computer skills, but not required.

Finally, I received a flyer for the 4<sup>th</sup> Annual Florida A.A. Archives Workshop being held February 24<sup>th</sup>, 2018 in Winter Park, Florida and will be including this in the 2018 Archives budget.

We have so many tools, it's exciting to discover and use them.

We developed a tri-fold display board concerning the process of getting badged to go into the Citrus County facility. It will likely generate as many questions as it answers but that's a good thing. Thanks to my colleague Bob for extra eyes on the project, our DCM and to my in-house tech support.

I have submitted a receipt for \$21.34 to the treasurer to cover the materials for our display.

In June we encountered a major obstacle: Because we are so thinly staffed with volunteers we frequently went in alone. The rule at Core Civic is 10 inmates to each volunteer. Mr Hubbard became uncomfortable with having to choose 10 from up to 20 inmates signed up. He didn't want to create a suspicion of favoritism. By the grace of God and facility cancellations, we were able to cover all meetings available to us in June. We are also blessed that Kathy G, who recently encountered serious health, problems has become well enough to rejoin our committee.

In the month of June there were 962 sessions with 800 unique visitors viewing 2409 pages. 63.79% of the users were new with returning visitors making up 36.21% of the sessions. The top ten pages visited were meetings, contact us, about, need help now, calendar, archive, where and when, minutes, mobile, links, and Audio. The top downloads were: Where and When, Audio Patrick, Audio Vella, Audio John S, SSASA flyer, Post Conference Flyer, Floral Park Flyer, Preconference Flyer, Minutes, and State convention flyer The bounce rate was 68%. For the old fashioned there were 5622 hits. 33.3% of visitors used mobile devices 55.6% desktop devices and 11.1% tablets.

**Old Business:**

1. District 28 Long Timers Speaker Meeting. The body approved the new date and location. Thursday, August 24, 2017 at the home of the Lecanto Group, Unity Church of Citrus County, located in Lecanto.

**New Business:**

1. Fall Workshop will be centered around the Grapevine Written and Oral Histories Initiative.. Other committees, Literature, Corrections, Archives, and treatment are encouraged to have visual presentations. Motion was made for the workshop to be held in early October – motion seconded and approved
2. District 28 Workshop Chair – Candidate for position not at meeting. Will read resume and vote at next meeting.
3. District 28 Service Chair Stipend/Mileage Reimbursement – A motion to change the way the Service Chairs are reimbursed was made and approved. Each Service Chair will receive a \$15.00 stipend for any expenses associated with attending the Area Assembly. If that Service Chair bore the expense of driving they may submit a request for mileage to be reimbursed at the .40 cents per mile rate using the distance from their home to the Area Assembly location. There is a \$65.00 combined cap on the reimbursement amount...for instance, the maximum a Service chair may receive is \$15.00 for general expenses and \$50.00 for mileage totaling \$65.00. After a motion, and second, the motion was approved.
4. Increase Archives Budget - \$24.05 to cover expenses for State Convention. A motion was made and seconded and approved.
5. Sober Sand Gnats – Request to hold Long Timers Speaker meeting on December 5<sup>th</sup> coinciding with their monthly pot luck on first Tuesday of each month. Motion, second approved.
6. Sexual harassment policy statement for groups. Discussion over issuing a sexual harassment policy that groups could use as a standard. Paige advised that GSO has a “yellow card” available for groups to use in order to deal with this subject. This will be added to old business for the next meeting to vote on how to pay for yellow card and safety guidelines.

## A.A. Traditions and Concepts

### **Tradition VII:**

The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then, too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

### **Concept VII:**

The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.
