In the month of July there were 924 visits to the website by 749 unique visitors who saw a total of 2610 pages or 2.82 pages per visit. The 10 most visited pages after the Start Page were Meetings General, Calendar, Where and When, Help Now, About AA, Archives, Legacies, Links, Contact, and Mobile. Meetings by day in order were Monday, Sunday, Wednesday, Saturday, Thursday, Tuesday, and Friday. Meetings by location in order were Hernando, Inverness, Dunnellon, Homosassa, Lecanto, Crystal River, Chassahowitzka, Beverly Hills, Floral City, Inglis, and Wahoo. 57.75% of the visitors used desktops, 39.44% phones and 2.82% used tablets. The bounce rate was a bit high at 64.79%%. For the few remaining "hitsters", there were a total of 6216 hits in July.

A need to address the topic of safety in meetings has become apparent by recent feedback from members representing several groups in District 28. GSO has published a Guideline, "Safety in A. A.: Our Common Welfare," which directly addresses many of the concerns facing us today. In setting the agenda for today, I chose to facilitate an in depth look at this material in hoping to foster an understanding that will reach the groups and members of our District.

The District like the Area and the General Service Office are by Tradition, Concept and Warranty not meant to govern but to serve.

When I started in Alcoholics Anonymous I attended meetings and joined a group where great pains were taken to create and maintain a safe environment free from prejudiced and predatory behavior. It was strongly suggested that our opinions and affiliations had no business in the rooms, in the parking lots or in the dinners for that matter where a new man or women might get the idea that A. A. was Catholic or Republican and have any reason at all to feel excluded and leave. Throughout the Traditions there is much wisdom safeguarding our open door to those who have a problem with alcohol. Practicing these principles and working a program of attraction in an effort to carry the message of hope and recovery to the still suffering is our primary aim not helping them find their way out.

At both the Area Assembly and the Florida State Convention, so we'll run by Ruth R. and her team, I heard again a phrase I would like to pass on..."Let's stop using the fourth Tradition to justify breaking the other eleven.

On a lighter note, I am looking forward to a Fall schedule full of workshops and events and so many opportunities to enjoy our fellowship and to serve.

# A.A. Traditions and Concepts

#### **Tradition VIII:**

Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we might otherwise have to engage non-alcoholics. Such special services may be well recompensed. But our usual AA Twelfth Step work is never to be paid for.

# **Concept VIII:**

The Trustees of the General Service Board act in two primary capacities:

- (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs.
- (b) But with respect to our separately incorporated and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities.
