Technology Committee: Steve N .January 2018 for December 2017 Usage: The District 28 website received 915 visits by 894 unique visitors seeing 2007 pages or 2.2 pages per visits in December. The ten most visited pages were calendar, meetings general, Where and When, About District 28, archives, help now, contact us, legacies, audio archives, and links. 65.53% of the visitors were on mobile devices, 27.59% were on desktops and 6.9% on tablets. 54% of the

visitors were returning and 46% were new. There were a total of 10,757 visits for 2017. For hitsters, there were 65,571 hits in 2017.

Ad Hoc Committee to Revise Structures and Guidelines: P. J. O. The current draft of the revisions was distributed. There was discussion and some disagreement among committee members as well as district concerning the definition of district. The Ad Hoc Committee will continue to work on that. It was suggested that both the general definition as well as the specific definition of District 28 might well be included in the final document.

Steve N. advised the process by which the Wahoo, Dunnellon, and Sand Gnats groups came to be included in District 28. Basically, those groups asked if they could be part of District 28, and the District voted affirmatively.

The creation of the District service position entitled Intergroup Service Chair and the removal of Intergroup Liaison position description from our Structure and Guidelines was discussed. More clarification was requested.

P.J. has followed the suggestion that service committees be arranged alphabetically by title in the revised Structures and Guidelines. He strongly requested that members compare the current draft with previous iterations which he has distributed.

Alt. DCM: P. J. O. He is in the process of changing the Where and When to clarify open/closed meeting distinctions with emphasis on language and demarcation.

A.A. Concepts and Traditions

Tradition One and Checklist: Our common welfare should come first; personal recovery depends upon AA unity.

1. Am I in my group a healing, mending, integrating person, or am I divisive? What about gossip and taking other members' inventories?
2. Am I a peacemaker? Or do I, with pious preludes such as "just for the sake of discussion," plunge into argument?
3. Am I gentle with those who rub me the wrong way, or am I abrasive?
4. Do I make competitive AA remarks, such as comparing one group with another or contrasting AA in one place with AA in another?
5. Do I put down some AA activities as if I were superior for not participating in this or that aspect of AA?
6. Am I informed about AA as a whole? Do I support, in every way I can, AA as a whole, or just the parts I understand and approve of?
7. Am I as considerate of AA members as I want them to be of me?
8. Do I spout platitudes about love while indulging in and secretly justifying behavior that bristles with hostility?
9. Do I go to enough AA meetings or read enough AA literature to really keep in touch?
10. Do I share with AA all of me, the bad and the good, accepting as well as giving the help of fellowship?

Concept I and Checklist: Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

- Does our group have a general service representative (G.S.R.)? Do we feel that our home group is part of A.A. as a whole and do our group's decisions and actions reflect that?
- Do we hold regular group conscience meetings encouraging everyone to participate? Do we pass that conscience on to the district, area, or the local intergroup meetings?
- Is the "collective conscience" of Alcoholics Anonymous at work in my home group? In my area?
- Where do we fit in the upside-down triangle of A.A.?
- Are we willing to do what it takes to insure that our democracy of world service will work under all conditions?
