Accessibilities Chair: No report.

Archives Committee: Submitted by Dean B.

He and Gina participated in the statewide AA Archives Workshop teleconference on July 10. The District 28 Archives Committee will be presenting the history of AA in Citrus County and the history of Our Tree Grows in Florida at the 5th Annual Archives Convention in Winter Park in February. The next teleconference will be on August 14. We attended the Area Assembly on Saturday, July 13, and participated in the Archives Workshop. We set up our projector to show the history of AA in Citrus County. Sorry to say, but the meeting was not well attended. The Miracles Group is interested in a movie night, one night a month, for Archives, and Denis S. has mentioned that he Crystal River Group might be interested as well. We are offering this to any meeting or group that is interested.

The archives are very important to me. I have been asked to bring the bulk of the District archives into storage, and I have no problem doing so, except that it would make it very difficult to present our archives to the populace of District 28 other than at the Founders Day and Gratitude Dinner events. Gina and I have completed the inventory of our Archives and what we propose is a traveling archives display that will be readily available to any and all of those interested in viewing them. Our books, literature movies and other items do not mean anything if they are hidden away except for two events or a workshop. I have prepared a spreadsheet of our inventory and the items in gray are what I would like to make available in our travelling display. They could be made available anywhere at any time. Please take time to let your GSRs and home group members review the inventory in the next few months and let us know.

Last month I talked about recording coffee conversations. We have a volunteer for our first coffee conversation participant, and as soon as I can get more familiar with the recording transcription software I will present it to District 28 and possibly have it in the next copy of the Journal. As of this morning the Jacksonville Archives agenda for tomorrow: Coffee Conversations. Twelve conversations have been recorded to date. They are all still in the editorial process, complicated by software and audio challenges. The voice recognition software has some bugs which are being worked out for a solution. So I will not be making the Jacksonville Archives Committee meeting tomorrow and will wait until they get the bugs worked out before starting the process of recording conversations.

Gina and I spent an immense amount of time inventorying every single item that we have, piece by piece, in the Archives, which is printed out in the inventory sheet. I have it on a spreadsheet I my computer. Any Big Book, meeting list or any other item that has any handwriting or inscription or dedication in it has a link in my

spreadsheet file. I plan on taking pictures of everything, including that link, to the spreadsheet, and in that way creating a digital archives display. I'll get with Steve in getting in on the system's Archives portion of the website. But, as you'll see, we have a lot of stuff that isn't very pertinent or personal to District 28, but the things in gray I would want to keep for the travelling archives display. All of our audio-visual stuff, CDs, DVDs, cassettes, all sitting in one place, and it doesn't do us any good sitting at my house or cold storage where people can't access it. The other thing to do, although expensive and complicated, is to have all of that stuff digitally recorded. Then it could be put on the website and accessed anytime. Jacksonville is doing that and it is costing a lot of money with a private contractor. In the meantime, I will make it available to anyone who wants to see it, at any time.

Ben was at the meeting and will be putting out a new Journal around the 1st of September. He would like to include more local content, looking for more stories of interest. In the Chair's report, Ingrid said she had gone to the Intergroup Workshop at the Area Assembly where they discussed various organization topics and how they relate to each other. It was concluded that Intergroups are autonomous, just as AA groups are autonomous, and each group can make its own decisions.

Where and Whens are very well stocked at all of our sites. I got to the Sheriff's Office Substation over in Crystal River where everything seemed to be untouched from my last visit.

Technology Committee/Website: Steve N.

We had 5301 visits in July by 4600 unique visitors. The bounce rate is still higher than 60%, but it is lower than in has been. We want to get the rate lower because that means people are staying. We are reaching a younger group than the Intergroup website, probably because the District 28 website is younger and hasn't been around as long. When we look at referrals, almost 57% of the referrals to the NCI site come directly to the site, not from a search engine. We also have a very high rate of mobile devices, 54.33% for phones, and 5.51 for tablets. The top ten pages visited this month indicate that apparently there were a lot of drunks in the Inverness area looking for meetings, as it was page #1, and then there was Meetings, Contact Us, Where and When, the Dunnellon meetings, the Crystal River meetings, the calendar, Homosassa meetings, Get Help Now, and then Thursday meetings. The most downloaded meetings were Where and When, the minutes, the Workshop flyer, and the Get Help number. We made a lot of updates to the Where and When. We have several flyers that we have created, and the calendar has been updated twice. I am working on how to develop a data base for a meeting guide for meetings nationally, it will be accessed through an app.

New Business:

A question from the floor addressed the issue of who would be responsible for making room reservations for the Area Assembly. Should it be the individual who wants the room, or should it be handled by a designated District person? Bob stated that it was his belief that each person who wanted to go to the Assembly would have the responsibility of making his/her reservation. They should contact the facility directly to take care of it. He advised that the reservations needed to be made at least thirty days in advance, as the rooms are reserved for the Assembly are released if not claimed thirty days before the date. Linda agreed that his position would work for people who could afford their own rooms, but pointed out that the District-paid rooms, one for men and one for women, should be reserved by a District official. Bob agreed and said he would reserve the rooms if people let him know at least thirty days before the date. Linda advised that she would help Bob if asked. There were no objections from the floor to that proposal.

Linda made a motion to increase the 2019 budget for Public Information, Line Item 5245, by \$20 to a total of \$45, as \$11.80 in excess of the budgeted amount has been spent. It was mentioned from the floor that, since PI and CPC had been consolidated, the requested amount could legitimately be taken from the CPC budget, from which there had been no expenditures. After discussion, Linda's motion as originally stated was seconded and passed.

DCM Bob asked if there were any nominations to fill any of the vacant service positions. No responses.

Bob addressed the next workshop, which will be the second half of the program on Service Work. Steve N. will present the program, which will take place on Saturday, September 7, from 2-4 p.m., at the location of the Miracles Group meeting place (Frank's Consignment), 21121 HWY 40 West Dunellon, Florida. Flyers for the program will be posted on the website and available for distribution.

Harry J. inquired as to whether any interest had been shown in signing up for the Hotline. Janet B. said her group has a form that they use, which she would share with him.

A.A. Traditions and Concepts

Tradition VIII:

Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire.
