Bob advised that he has found a new place to have meetings when we are ready to resume inside meetings. It is the Beverly Hills Community Center. It has a large open room so it could be used even during the Coronavirus, as it would provide adequate space for social distancing. They would charge \$10 per hour. We will need an indoor facility when the weather turns cooler. In the past there have been concerns about meeting at a facility that is centrally located, but it is difficult to find a facility that is suitable. Finding a facility that meets our criteria is most important. The proposal was tabled for the time being.

Due to the unforeseen circumstances created by the Coronavirus and in the absence of any objection, Linda, Treasurer, P. J., Secretary, and Bob, DCM, were all willing to continue service in those positions. They were reappointed by unanimous vote. Bob reported that all of the remaining District officers and Committee chairpersons would remain in those positions until further notice.

The proposed budget for the 2021 fiscal year was approved.
