Reports

Secretary: P. J. O.

The Bank balance was in good shape because the groups have been so good in their contributions but our expenses have been cut because of Covid, especially with regard to there being no Assembly expenses. We still have some storage expenses.

Archives: Denis S., Chair

Denis said he is facing some issues because this is new to him, but Dean has been a great help. Denis will have the Archives on display at the Spring Fling, Clint will help him as will Dean. With regard to recording the stories from old-timers, Denis reported that he had previously recorded the story from a gentleman who was 95 years old and had 61 years of sobriety, but was going to interview him again. The man's wife died and he sold the boat he had been living on; he didn't drink but was doing 60 meeting is 60 days to deal with it.

Men's Corrections Report: Bob M.

Bob advised that work had finally begun on implementing the capability for Zoom meetings in the jail. He will try to get the Zoom meetings set up; Bob will meet with him soon. Also, a new Program Director has been hired, so it shouldn't be long before an orientation program is in place and AA will be allowed to go into the facility. They hired from within the jail staff this time, a counselor. There are still some communication issues, so he can make direct contact.

Grapevine: Chris J.

I have registered on the Grapevine website and they have sent me a packet. Denis has given me some Grapevine information boards which I can use at the Spring Fling, and has been very helpful. I hope to have a good setup in time for Founders Day.

Bob noted that an outside event was being considered for Founders Day on June 12. All those at the meeting were favorable to that idea.

PCP/Public Information: Janet B.

She thanked Bob for meeting with her and helping her out. She reported that she will not go back to the "Welcome Center" in Crystal River because they would not accommodate her. They throw her literature away. County Probation, State Probation and Parole offices were shut

down for a while because they could not use the Court. Also, they have moved. The Visitor's Center was not accessible, but it has been moved to City Hall. She has visited all of her usual stops, including the Health Department. A literature distribution location at the Y was also identified. Some of the people are very accommodating, and even thank her for her service.

Website/Technology: Bob has been in frequent contact with Steve regarding the Website and meetings so everything is up to date. Steve has a posted a lot of information on the site.
