

DISTRICT 28 MEETING MINUTES
DECEMBER 2021

OPEN:- DCM Bob M. opened the meeting with a moment of silence followed by the Serenity Prayer. The Declaration of Unity and the Responsibility Statement were also read.

He said he is also interested in the history of both Clubs within District 28 as well as the history of Institutions and Early Members. Dean also said he will be continuing the work of recording longtimers. Denis S. thanked Quentin B. for his support of the Archives at the recent Gratitude Dinner.

CORRECTIONS:- Both Bob M. and April W. reported that they are hoping to resume post Covid activities soon and are hoping to have orientation sessions so that all volunteers can be brought up to speed.
